## Description and designation of the product:

The halogen-free, flexible double-walled corrugated pipe has been specially developed for air distribution.

Its double-shell design, with an inner smooth and an outer corrugated layer, ensures sufficient tightness, excellent flexibility and considerable mechanical resistance.

The inner wall of the tubes is made with a special additive that guarantees antistatic, antibacterial and antifungal properties. The material used and its properties fundamentally affect the behavior of the whole system, therefore the tubes are manufactured exclusively from primary raw materials (HDPE), without the addition of regranulate.

Halogen-free, flexible double-walled corrugated pipe is produced with a blue outer wall and an inner white wall.

The system consists of flexible PE-HD pipes, couplings, sealing rings and closing plugs.

Length of pipes KOPOFLEX PLCA pipes is 50 meters (tolerance + - 1%). Both ends are equipped with protective plugs. The indisputable advantages of plastic pipes are simple handling and assembly, low weight and easy cleaning. It is fully compatible with common system components.

By fulfilling the conditions in accordance with the above, the CCZ marking was placed on the product.
